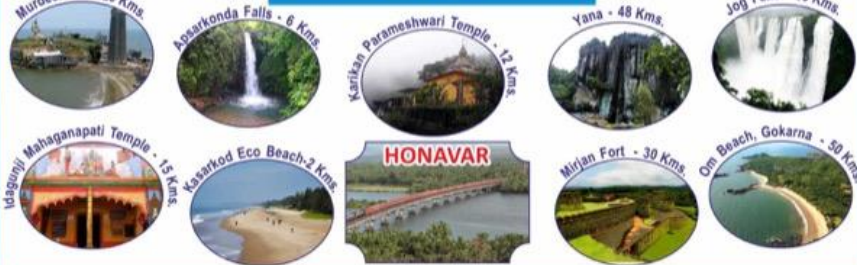

**System of play :** The championship will be played under the FIDE Laws of Chess and Swiss system. Totally Eight to Nine rounds shall be played

**Time Control :** 25 minutes + 10 seconds.

**Tie Break :** Tie Break will be announced in Players Meeting.

**Walkover time :** 10 minutes only

**Protest :** Protest, if any, against the decision of the chief arbiter shall be made in writing with a protest fee of Rs. 500/- within 15 Minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld.

**Appeals Committee :** Before the commencement of the tournament, a five member committee of Appeal with two reserves shall be formed from amongst the senior participants and officials present at the Manager's meeting to be held at the venue on the Inaugural Day. All the members and reserves shall be from different districts. No member of the Committee can vote on a dispute in which a player from his own district is involved and in such case the reserve member(s) shall take his place in the committee.

**Interpretation :** For interpretation of the rule(s) and deciding any point not covered by the above rules of the tournament, the decision of the tournament committee/Chief Arbiter shall be final and binding on all. The tournament committee/Chief Arbiter has every right to take any decision or amendment to those rules, without notice. Such changes will however be displayed in the tournament hall.
