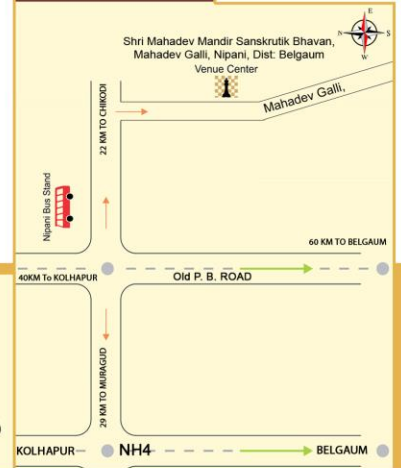

## RULES & REGULATIONS

**System Of Play :** The tournament will be conducted as per latest FIDE law and Swiss system with 9/10 rounds with time control of 25 min. each & 5 second increment for each move.

**Tie Break :** The final ranking order of players is determined by the numbers of points scored. If at the end of the tournament two or more players are tied for the same place the tie shall be broken according to Buchholz tie break score.

**Protest :** Protest if any against the decision of the chief arbiter shall be made in writing with protest fee of Rs 500/- (Rs. Five Hundred Only) within fifteen minutes of the occurrence of the incidents to the appeal

**Committee.** The protest fee will be refunded if the appeal is upheld.

**Appeal Committee :** Before commencement of the tournaments an appeals committee will be formed amongst the senior participants present at the players meetings.

**Withdrawals :** A player may withdraw at any stage of the event after informing the chief arbiter in writing.

**Disqualification :** No participant will leave the venue before the prize distribution function without the permission of the chief arbiter.

**Right Of Admission :** The organizer NUF reserves the right to admit or refuse any entry without assigning

All age group prizes will be given in their concern age only.
